In the event that we are in breach of any of the above sections, Scicom may immediately revoke the contract award, or terminate the contract for the Business Transaction(s) without any liability whatsoever on the part of Scicom to the Vendor. This is without prejudice to any other rights or remedies that Scicom may have or any other appropriate action which Scicom may seek under the terms of the applicable tender/contract or applicable laws and regulations.
